American Profit Employees Profit American Vets

ARMinG Heroes (www.armingheroes.org), the accounts receivable management industry's non-profit dedicated to serving U.S. military veterans (hence "ARM" in "ARMinG"), has received a generous donation from American Profit Recovery (www.americanprofit.net) on behalf of its employees. The donation was made last week to support the organization's **First Annual Veteran's Day Charity Fundraising Drive** ("the drive").

To explain why and how they decided to show their support with this donation, American Profit Recovery released the following statement. "We found out about ARMinG Heroes through insidearm.com, and the donation [we made] came from money raised by our 50-plus employees this summer in what we call our 'Charity of Choice' program. We give our employees the opportunity to nominate charities close to their hearts, and then provide opportunities to donate throughout the summer by [letting employees pay] for casual or raffling off sports tickets ... We felt like [ARMinG Heroes] was the right fit for part of this program's money raised."

The drive began at 8:46 AM EST on Saturday, September 11, 2010, and will conclude at 11:00 AM PST on Veterans Day, Thursday, November 11, 2010. The starting time coincided with the anniversary of the first attack on the World Trade Center in 2001, while the ending time coincides with the anniversary of the official cease fire at the end of World War I, a date later adopted for use as Veterans Day in the United States.

The goal of the drive is to raise \$10,000 or more and disburse most or all of the funds in time for the holidays, both directly to veterans who have applied for aid and indirectly through in-kind donations to one or more large national veterans' charities on behalf of the ARM industry. Through close of business on October 27th, the organization has received dozens of donations from companies, large and small, and from individuals, ranging from \$50 to more than \$500, with an average donation size just under \$300.
